Step 1: Click "Register Your Profile"



Step 2: The following screen will show and client has to read carefully and agreed the terms and conditions to use GIBL Internet Banking System.

The Bank reserves the right to demand explanation from the User within 7 (Seven) working days regarding any matter pertaining to money laundering law of the Country.

12. This Agreement is subject to all applicable operating circulars of Bangladesh Bank, Global Islami Bank Limited and any other applicable provisions of Laws of the land. This Agreement shall be binding upon and insure to the benefit of the parties hereto and their respective legal representatives, successors and assignees.




